

Application for a toddler allowance

The sooner your children go to school, the more opportunities they will have in life. This is why the Flemish government rewards school-age children in the form of the extra allowance for children aged three and four.

You are entitled to a toddler allowance for your three-year-old if your child:

- is enrolled in an ordinary or special preschool education that is financed or subsidised by the Flemish Community.

You are entitled to a toddler allowance for children aged four if your child:

- Is enrolled in an ordinary or special preschool education that is recognised, financed or subsidised by the Flemish Community; has had sufficient attendance during the
- current or previous school year.

Do you meet all the criteria and live in Flanders?

If you already receive child benefit, you do not need to do anything. The preschool will automatically forward your child's enrolment and attendance record. You will automatically receive the extra allowance for children aged 3 and 4 at the earliest in the month after their 3rd or 4th birthday.


